SUBJECT DESCRIPTION	
9. Outline of career: Don Juan Filhiol was born in Eymet, in Perigord, France, Sept. 20, 1740. Filhiol was a relative of the Duc de Grammont. He arrived in New Orleans after a period in Santo Domingo in May, 1779, in time to take part in Don Bernardo Galvez's conquest of West Florida and Baton Rouge. As reward for gallant conduct in this campaign, the King of Spain appointed him a Captain in the army and commissioned him Commandant of Militia. In this capacity he served in the garrison at the Post of Opelousas where he met and married the beautiful Francoise Poiret, member of a prominent and wealthy family of Opelousas. Galvez was succeeded as Governor by Col. Estevan Miro who assigned Filhiol  10. Outline of career (continued): the duty of establishing the Post of Ouachita with instructions to take a company of soldiers and settlers and establish a Spanish outpost on the Ouachita River. As partial recompense for these duties he was given a large grant of land to be located by them in this wilderness. Sometime around 1783 he made this long and difficult journey from New Orleans, up the Mississippi, Red and Ouachita rivers into a very sparsely inhabited region. Filhiol located his first post at Ecore a Fabri, the present site of Camden, Ark., in 1783. In 1784 he transfered the site of the new post to a more favorable location down river at the Prairie des Canots, site of present day Monroe. Filhiol served as Commandant for 15 years resigning in 1800. He located grants for himself on both sides of the river at the present site of Monroe.
